

## S4C Clic 2019 Prize Draw ("the Competition") Full Terms and Conditions

The following terms and conditions are relevant to this Competition.

- 1. The Competition is open to all UK residents aged 16 or over, except for individuals employed by S4C or their close family and other companies that have direct links to this Competition.
- 2. The prize for the Competition winner will be a 49" HD smart television.
- 3. Every individual who registers for an S4C Clic account between 27 May 2019 and 10 August 2019 and who meets the eligibility criteria will be automatically submitted as an entry to the Competition. Entries submitted by any other method will not be included.
- 4. The closing date for the Competition is 10 August 2019. Entries made after the closing date will not be entered into the Competition.
- 5. After 11 August 2019 one winner will be chosen at random from all the correct entries received on or before the closing date of the Competition using a computer process. S4C's decision regarding the winner will be final and no correspondence will be answered.
- 6. The winner will be contacted by S4C via email after 11 August 2019. If S4C is unable to contact the winner or if it's not possible to make arrangements to distribute the prize following reasonable attempts by S4C to do so, S4C reserves the right to select another winner out of the Competition entrants.

S4C reserves the right to alter or amend the Competition or these terms (including eligibility requirements) at its sole discretion with or without prior notice (i) in the event of any occurrence outside S4C's reasonable control (ii) to ensure the Competition is run fairly and (iii) to ensure compliance with applicable laws, regulations and guidance.
- 9. In the case of any dispute regarding the terms, the prize, the result or any other issue relating to the Competition, S4C's decision will be final and no correspondence will be entered into.
- 10. By entering the Competition you agree, confirm and warrant that:
  - i. all information provided by you to S4C is correct, current and complete;
  - ii. if you win the Competition, S4C can use your name and photograph for publicity purposes; and
  - iii. your entry and any information submitted by you is personal to you.
